WHO WE SERVE...



For FFY 2019:

There were 17 CAAs, serving 298,877 people with low incomes who were living in 120,874 families.

CAAs served 26,117 people who lacked healthcare, 54,223 people who reported having a disability, 28,016 senior citizens, 122,253 children living in poverty, and 7,339 veterans.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

What kind of RESOURCES do CAAs have?

Iowa Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1211 non-profits
- 1,635 for-profits
- 722 faith based organizations
- 371 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY19 there were 18 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

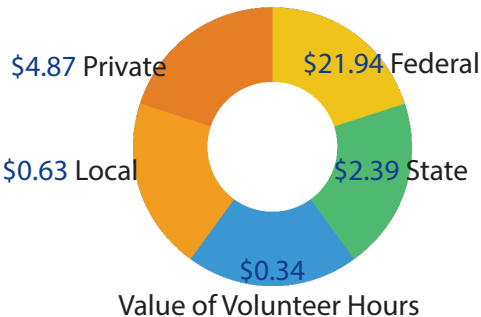


There were 353,545 hours of volunteer time donated to CAAs in Iowa.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Iowa's CAAs leveraged \$30.17 from federal, state, local and private sources, including the value of volunteer hours.

- \$7,430,545 in CSBG funds were allocated in support of CAAs in Iowa in FY19.
- Including, all leveraged funds Iowa had \$229,070,779 available to the CAA network to improve the lives of people with low incomes in FY19.



17 CAAs in Iowa also operate the Low Income Home Energy Assistance Program (LIHEAP).



16 CAAs in Iowa also operate the Weatherization Assistance Program (WAP).



15 CAAs in Iowa also operate a Head Start Program.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

598 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

25,111 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

5,607 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

1,538 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



HEALTH

43,985 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

CIVIC ENGAGEMENT

564 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.
