IX. Update on community member and University of Iowa meeting

Michelle Reuss, Marlu Abarca, Jeannette Martinez and Sonia Reyes Snyder met with Administration staff from the University of Iowa Hospitals and Clinics on July 22, 2016 to discuss their policy and procedures when denying care to patients who are undocumented and the lack of tack and inappropriate comments made by their Chief Administrative Officer to Sonia Reyes-Snyder; this due to information provided by Iowa Lutheran Hospital and Gerardo Sanchez's wife indicating that The University of Iowa Transplant Center refused to admit Mr. Sanchez due to his inability to pay.

University of Iowa Hospitals and Clinics staff informed those present at the meeting on July 22, 2016 that they in fact rejected the Commission's and many community members' request to admit Mr. Sanchez solely on his inability to pay and that this decision was made without receiving a formal clinical referral from Iowa Lutheran Hospital or any contact with the family.

University of Iowa Hospitals and Clinics and commissioner have a pending follow up meeting to discuss more specifics about the specific situation of Gerardo Sanchez and the referral & case evaluation process.

Sonia will follow up with Mr. Sanchez wife to obtain hospital records from Iowa Lutheran Hospital.
