KEN HERHMI PAWL:

- Tangka lut fehternak catlap (kum 19 in cunglei chungkhar milu zaapi te caah)
A luan cia ni 30 chung ban catlap (check stubs), cun ngunkhua khirhnak siloah zatlang zohkhenhnak catlap (Social Security or tax return)
- Zatlang zohkhenhnak (Social Security) nambat a zaapi in chungkhar milu (catlap pawl an herh)
- Nai hrawng mei (heat) caah hmanmi man
- Nai hrawng mei (electric) caah hmanmi man

NI HLAWH A HMUHMI HNA:

Zaangfahnak tein a luan cia ni 30 chung ban catlap (check stubs) a nithla a lang chihmi, siloah ramkomh ngunkhuai (federal income tax return) khirhnak catlap kawpi (copy) rak i put.

TANGKA LUT RIKHIAHMI:

Tangka lut ah a tanglei hi aa tel chih dih: Zatlang bawmhnak (Social Security Benefit), Tangka lut bawmhnak (Supplemental Security Income), Chungkhar rian tuannak caah bawmhnak (Family Investment Program), Ralkap hlun bawmhnak (Veteran's Assistance), Rian sunh tik ca aamah-khan (Unemployment Insurance), le pan-sen (pension). A luan cia ni 30 ca na ban catlap (check stubs) zong rak pu chih.

PUMPAK RIAN NGEIMI/LO THLAU (SELF-EMPLOYED/FARMERS):

A hnuvik ramkomh ngunkhuai khirhnak catlap (federal income tax return) zong rak pu chih.

FIP A NGAHMI HNA:

DHS biachahnak catlap rak i put, siloah a herhmi catlap kongah naa neihnak bik zung kha rak chawn hna.

Ngakchia bawmhnak a hmumi na si ahcun, cucu zohfel chap a hau lai.
